Since January 2017, your office has been deducting P100.00/ month on our judges members' salaries from the MetCJAP as membership fee.

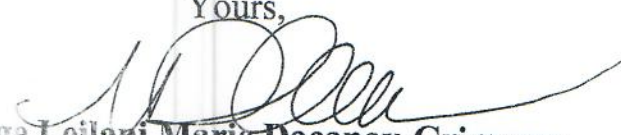

Board Resolution No. 2017-6

“Authorizing the MetCJAP Board of Trustees to Coordinate with the Fiscal Management and Budget Office (FMBO) thru the EDP Division of the Supreme Court to Implement the Automatic Deduction of the Increase of the MetCJAP Membership Fee from P100.00 to P200.00/ month”

WHEREAS, from P1,200/ annum, the MetCJAP membership fee has been increased to P2,400 by a majority vote of its members;

WHEREAS, the Board of Trustees is hereby authorized to coordinate with the Fiscal Management and Budget Office (FMBO) thru the EDP Division of the SC to implement and facilitate the automatic deduction of **P200.00 monthly** from the judges members' salary to cover the payment of the annual MetCJAP membership dues;

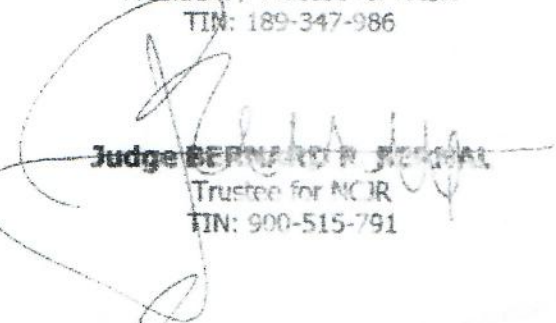
