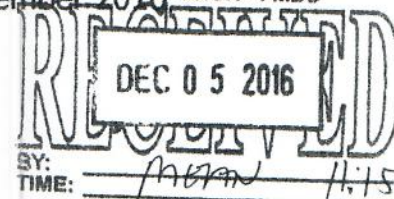

Dear Mr. Montalvo,

The **Metropolitan and City Judges Association of the Philippines, Inc. (MetCJAP)** is an aggregation of Judges of the Metropolitan Trial Courts (MeTC) and Municipal Trial Courts in Cities (MTCC).

We have learned that until January 2016, the EDP Division has been deducting the amount of Five Hundred Pesos (P500.00) annually (every January) from the salaries of a few MeTC and MTCC Judges. However, said arrangement/practice has been abrogated by the present Board of Trustees of the MetCJAP.

In lieu thereof, we are submitting to your good Office, MetCJAP Board Resolution dated November 23, 2016 authorizing the deduction by your Office of the amount of **One Hundred Pesos (P100.00) monthly** from the salaries of Judges of the MeTCs and MTCCs, or the total amount of **One Thousand Two Hundred Pesos (P1,200.00) every year** as their membership fees in MetCJAP.

May we therefore request that said deduction by your Office be effected starting **January 2017** and every month thereafter until amended or revoked by MetCJAP.

We shall be glad to hear from you on this matter to discuss the mode of remittance to MetCJAP of the collected amounts and such other details.

MetCJAP Board Resolution
Re: Automatic Deduction of the Annual MetCJAP Membership Fee from Judges' Salary

WHEREAS, the annual membership fee for the MetCJAP is ONE THOUSAND TWO HUNDRED PESOS (Php 1,200.00);

WHEREAS, in order to maintain good standing as member of MetCJAP, the payment of the annual membership fee is required;

WHEREAS, in order to facilitate the collection of the annual membership fees, the Board agreed to propose the automatic deduction of the amount of **Php 100.00 every month** from their salaries;

WHEREAS, the members of the MetCJAP during its 18th National Convention on September 28-30, 2016 at the Iloilo Convention Center voted by a majority vote of 83 "YES" votes to APPROVE the proposal for the automatic deduction of Php 100.00 monthly from the judges' salary to cover the payment of the annual MetCJAP membership dues;

WHEREAS, the Board of Trustees is hereby authorized to coordinate with the Fiscal Management and Budget Office (FMBO) thru the Electronic Data Processing (EDP) Division of the Supreme Court to implement and facilitate the automatic deduction of **One Hundred Pesos (P100.00) monthly** from the salaries of **Judges of the Metropolitan Trial Courts (MeTC) and Municipal Trial Court in Cities (MTCC)** being members of MetCJAP, as their annual membership fees;

THEREFORE, it is hereby **RESOLVED** that starting **January 2017**, the FMBO thru the EDP Division of the Supreme Court shall be authorized to automatically deduct the amount of **ONE HUNDRED PESOS (PHP100.00) MONTHLY** from the salaries of Judges of the MeTCs and MTCCs to cover their annual MetCJAP membership fee of One Thousand Two Hundred Pesos (P1,200.00);

IN VIEW THEREOF, it is hereby **RESOLVED** that the Board shall immediately coordinate with the EDP Division of the FMBO of the Supreme Court for the implementation of the automatic deduction of the amount of **ONE HUNDRED PESOS (Php 100.00) monthly** from the salaries of MeTC and MTCC Judges as their membership fees.
